- **3.1. Physical State:** Powder
- **3.2. Appearance:** COLORLESS OR WHITE CRYSTALS, OR WHITE CRYSTALLINE POWDER
- **3.3. Odor:** Odorless.
- **3.4. pH:** 9.0, 35 °C

**5. Handling/Storage**

- **5.1. Storage:** Store in a cool and dry place and Keep away from strong light and heat
- **5.2. Handling precaution:** Keep away from sources of ignition. Ground all equipment containing material.

**6. Exposure Control**

- **6.1. Engineering Controls:** Use process enclosures, local exhaust ventilation, or other engineering controls to keep airborne levels below recommend edexposure limits. If user operations generate dust, fume or mist, use ventilation to keep exposure to airborne contaminants below the exposure limit
- **6.2. Respiratory protection:** NIOSH/MSHA or European Standard EN 149 approved respirator
- **6.3. Eye Protection:** Protective eyeglasses or chemical safety goggles

- **7.1. Hazardous overview: Taurine is Slightly hazardous in case of skin contact (irritant), of eye contact (irritant), of ingestion, of inhalation**
- **7.2. Contact with eyes:** May cause eye irritation.
- **7.3. Contact with skin:** May cause skin irritation.
- **7.4. Ingestion:** May irritate the tissues of the mouth, esophagus, and other tissues of the digestive system
- **7.5. Inhalation:** May cause irritation to the respiratory tract and gastrointestinal

- **8.1. Contact with eyes:** Flush immediately with plenty of water for 15 minutes and seek medical advice
