## 3. HAZARDS IDENTIFICATION

May cause sensitization by skin contact.

## 4. FIRST AID MEASURES

**Symptoms and effects** Dust may be irritating to the respiratory tract and cause symptoms of bronchitis. Repeated contact may cause skin sensitization.
